- 1. Product is specially formulated for use with Nu-Calgon's Drip Feeders. For specific instructions on drip feeding with this 5 gallon package, refer to product bulletin 3-422 or consult Nu-Calgon. Generally, use one gallon of Cal-Treat 233 per month for every 30 tons of cooling capacity.
- 2. When drip feeding, it is critical that:
 - This container be vented by leaving cap very loose or by punching a small hole in neck below threads.
 - Container be secured on tower, evaporative condenser, etc. by means of 5 gallon jug holder (Nu-Calgon part no. 4607-0).
