- 2. Circulate cleaning solution for approximately eight hours. Be sure to vent system from point of highest elevation in order to avoid gas buildup. If possible, heat cleaning solution to 120-130°F to aid in cleaning rate.
- 3. Flush system thoroughly with fresh water. Add fresh water or a formulated premix Nu-Calgon glycol product.
- 4. Add appropriate Nu-Calgon corrosion protection product such as Ty-Ion B20, Ty-Ion B-14A, Freez-Kontr'l or Freez-Therm depending on specific application criteria. For specific questions, please contact Nu-Calgon.
