

DIRECTIONS FOR USE

NOTE: PROTECT EYES AND SKIN WHEN USING THIS PRODUCT.

For A/C Condensate Lines: Ensure condensate line is plumbed to a sanitary sewer. **For routine maintenance,** cap the end of the condensate line. Pour 6 to 8 ounces of Drain Solve into the condensate line. Refrain from use in metal pans and avoid contact with coil. Fill line with water, allow to work for 15 minutes. Uncap and rinse thoroughly with two gallons of water. **For blocked lines,** remove as much standing water from block as possible. Pour 16 ounces of Drain Solve into line - do not fill condensate pan or allow product to touch coil. Fill line with water, allow to work for 15-20 minutes. Rinse thoroughly with two gallons of water.

For Drains, Kitchen, Bathtub, and Lavatory Drains: Pour 16 ounces directly into drain. Allow to work for 15 to 20 minutes. Flush with warm or hot water. Repeat if necessary.

For Basement and Large Type Drains: Pour 32 ounces directly into drain. Allow to work for 15 to 30 minutes. Flush with warm or hot water.

CAUTION: DO NOT MIX WITH OR USE WITH ANY OTHER TYPE OF CHEMICAL.

Do not reuse empty container. Rinse thoroughly with water and discard.
