When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport cylinders. Suck back of water into the container must be prevented. Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt. Cold burns may occur during filling operations. Containers and delivery lines may become cold enough to present cold burn hazard. Never allow any unprotected part of the body to touch uninsulated pipes or vessels that contain cryogenic liquids.
